1 Basis of Accounting and preparation of financial statements:



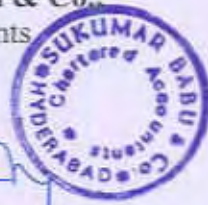


